Election of all Office Bearers at 5-55pm. Colin handed the meeting back over to Murray Forman and welcomed in the new Committee.

President Murray Forman gave a second report on the status of the Chapter. He then presented a proposal of a nomination to the committee for Life Membership, submitted by Ronald Barrett, to make the following members Life Members. Murray Forman, Wendy Forman, Louis Rokas, Lon LeMaster, Neil Fletcher, Wayne Heale. Andrew Christopoulos. This stated that the above members served outstanding merit in the initial starting of our Chapter, with financial investment and service to the Chapter. These members have also indicated that they will not require the Chapter to repay their investment. By making them Life Members, this would also remove the financial liability of the Chapter.

Murray Forman then explained the initial start up of the Chapter where the above members paid \$500 each in cash and service. This being a \$2,500-00 liability. Colin Morris commented about making them Founding Life Members, Murray responded by saying we already have Founding Members who had purchased Leather Jackets to assist the finances of the Chapter. Gary Wilkinson inquired about the criteria of the Life Membership in the Constitution, Murray then read out the Constitution to the committee.

Scott Morden then moved a motion that as a kind gesture of the Chapter and being in a sound financial state, that the cheque be sent to the nominated Life Members and if they wished, they could then return it to the Chapter or keep the cheque. This puts the decision directly back onto the nominated member. It was also discussed that the committee decide the terminology of the Award. The motion was then moved by Richard Stones, Second by Colin Morris. Passed by all members present.

Murray then went on to express gratitude to all our sponsors who have supported the Chapter through the year and for all Chapter Members to use their services to show their appreciation.

Colin Morris asked if it was possible to name all the 25 Founding Members in the next Newsletter. Murray Forman will give the information to Gary for publication in an upcoming Newsletter.

Murray Forman then opened the discussion of the Membership Fee of \$35-00. Colin Morris asked if you paid multiple years, could you get a discount. Gary Wilkinson stated that he felt it should stay the same.

After a long discussion, the motion was put forward by Gary Wilkinson that the \$35 stays the same. Colin Morris seconded the motion. All members except Neil Fletcher accepted. The motion was carried.

Murray Forman talked about when the USA Membership was due, that the Chapter charges the member for both the Chapter fees and the USA fees would then be paid by the Chapter.

Murray Forman read a letter from Eric Mortimer on this exact topic where Eric said "no other Chapter was doing this and that he thought that it was not a good idea". Peter Whiston then spoke about new members who join on the web site, to put in the charge of the American Chapter fee as a joint fee, then the renewal would be left up t the new member in the following year.

Murray Forman then explained about membership through the National website, that some members joined for multiple years, so this would also complicate the issue. Gary Wilkinson will look into options on this subject. Martin Kilbane stated to make the membership renewal form with the option to do multiple years. The committee will look at this option.

Murray Forman gave a report about the NSW Corvettes Unlimited Car Club forum where a person on the forum was very derogative about NCRS Australia Inc. And that the statements that were put on this forum were totally incorrect. He then contacted the President of the Club and voiced his disapproval. The he contacted the carrier for the NSW Club forum and informed them of the situation, he then immediately removed all wording relating to NCRS Australia from their forum.

This is a fine example of how somebody can hide behind a forum, use a call name and make defamatory comments about anybody they wish. So in the future, if any Chapter members come across these instances, please contact Murray immediately. Murray then spoke about a committee which he has been asked to form by the Directors of NCRS. This being the Presidents of all the International Chapters, New Zealand, England, Dutch and Australia, also with the assistance of Tom Barr to put forward a proposal to the Board of Directors for the next stage of judging after Flight Judging for the International Chapters exclusively.

This Award would be called the INTERNATIONAL MARK OF EXCELLENCE AWARD.

Murray has now completed the proposal and presented it to Roy Sinor to be put forward at the next Board Meeting. We are waiting for their response. With no further General Business Murray then closed the meeting at 6-45pm.

We had 7 magnificent cars for judging and they scored:



## Vale: Donna Mae Mims: Contribution by Colin Morris

Donna Mae Mims, 82, of Bridgeville, PA. died Tuesday, Oct. 6, 2009. Born July 1, 1927, to George Warnoch and Margaret Bodner. She was known by many as the "Pink Lady,""Think Pink,""Donna Amazing" and even "Free Maui". Donna started racing in 1958 and was the first woman driver ever to win a Sports Car Club of America National Championship H Production 1963. Her career and involvement in Yenko led her to racing such cars as the Camaro, Austin Healy, MG, Corvette and Corvairs.

She worked for Yenko Chevrolet and Yenko sports car division as executive secretary for both and was the liaison for design and production with the Yenko sports car division with such cars as the Deuce, Camaro, Nova, Chevelle and Corvair. She worked closely with Zora Arkus Dontuv, Ed Cole and the pioneers of Chevrolet Racing. She coordinated parts delivery and car development of Corvette Race Cars in Canonsburg. She raced many times in Sebring, Daytona and Riverside.

Donna Mae was as original participant in the original Cannonball Run where her 1968 Cadillac Limo was wrecked with her teammate behind the wheel. She was known as being able to go toe to toe with some of the best drivers in the country at speeds up to 140 miles per hour.

She was an avid longtime member of the SCCA and her other interests included Jazz music and teaching Sunday school as an active member in Mt. Lebanon United Methodist Church.
